- a. Measured at the discharge terminal point of the compressor package in accordance with ISO 1217, Annex C; ACFM is actual cubic feet per minute at inlet conditions.
 - b. The operating pressure at which the Capacity (item 3) and Electrical Consumption (item 11) were measured for this data sheet.
 - c. Maximum pressure attainable at full flow, usually the unload pressure setting for load/no load control or the maximum pressure attainable before capacity control begins. May require additional power.
 - d. Total package input power at other than reported operating points will vary with control strategy.
 - e. Tolerance is specified in ISO 1217, Annex C, as shown in table below.

NOTE: The terms "power" and "energy" are synonymous for purposes of this document.
